UNIVERSITY NETWORK ID (UNI)

Your UNI, consisting of your initials followed by a four-digit number, is the key to accessing computer services and electronic resources at Columbia. Your UNI serves as both your on-campus ID number and your columbia.edu email address.

Your UNI also allows you to gain access to all official University email messages, restricted Columbia University Libraries information and services, student grades, billing, and registration information.

LIONMAIL

LionMail is a state-of-the-art email, contacts, and calendaring system for your University email account interface.

Some of the advantages of LionMail:

- 25 GB mail storage
- Log in with your UNI and password
- Desktop and mobile log-in ability
- Access to the Columbia directory from within LionMail
- Tag messages with multiple labels and choose from multiple importance markers
- Fast searching, including within the full message text

ACADEMIC PLANNING SESSION

Dual BA Program students preparing to transition to their third and fourth years at Columbia must attend an online Academic Planning Session (APS). The APS is a mandatory small-group session led by your academic advisor that provides new students with an overview of academic requirements and information about course registration and GS policies. There will be separate APS sessions for students in STEM majors and students in AHSS majors.

APS for STEM majors (Neuroscience, Geoscience, and Mathematics):

APS for AHSS majors (Classics, English, European Studies, Film, History, History of Art, Middle Eastern and European Languages and Cultures, Philosophy, and Religion):

Tuesday, February 17
3 PM EST / 8 PM Irish time

2:30 PM EST / 7:30 PM Irish time

Your academic advisor will reach out in the coming weeks to invite you to register for the session that works best for your schedule.

You will not be able to register for fall courses if you do not attend this APS. If you have scheduling conflicts, please reach out to your GS Academic Advisor. Once you attend an APS, you will be able to register for classes.

Once you register for your preferred APS date, you will be emailed a link to participate in the Virtual Advising Session in advance of the session.

HOUSING APPLICATION

Students within the Dual BA Program with Trinity College Dublin are guaranteed access to Columbia University housing as they prepare to make the transition to New York. The city's many and diverse neighborhoods combined with an extensive public transportation system offer a variety of housing options that are convenient to the Columbia campus.

COLUMBIA HOUSING

School of General Studies students are housed in facilities operated by Columbia Residential. Since few studio apartments are available, GS students are usually accommodated in apartments or dormitory-style suites shared by other Columbia students; typically each student has his or her own bedroom while sharing kitchen and bath facilities.

HOUSING ELIGIBILITY

To be eligible for University housing, you must be a full-time student (meaning you must register for and complete at least 12 points each semester). Full-time student status is also a requirement for maintaining your student visa. Please note that students who choose not to apply for housing leading up to their arrival in New York will not be guaranteed GS housing at a later date; while every effort is made to offer housing to all GS students who express an interest in living in University Apartment Housing, this guarantee for Dual BA Program students is limited to the period of time before they arrive on campus.

It is easier to be assigned to Columbia Residential housing as a student who is new to the university than as a continuing student. If you plan to apply for housing, **it is best to do so now, as the timeliness of your application will impact your housing allocation.** You may decline an offer if you decide you do not want Columbia Residential Housing.

APPLYING FOR HOUSING

Note: Only students who have accepted their offer of admission, paid their deposit, and activated their UNI will be able to access the Housing Portal and apply for housing. To apply for housing, please follow these steps:

1. Review the Columbia Residential Overview and Essentials and Types of Accommodations located here: residential.columbia.edu/content/students
2. Sign up for a [My Housing Portal](#) account log-in and complete the housing application here: residential.columbia.edu/content/students/apply



You will need your **Columbia University ID (CUID/PID)** for this application. Your CUID is noted in your letter from your academic advisor.

The application for housing for the 2026-2027 academic year will open on March 20, 2026. To be considered for housing for the coming term, your Columbia Residential application must be received by April 15, 2026. A Columbia Residential application is not binding, so if you are assigned an apartment you may decline the offer. There is a \$20 administrative processing fee for all applications. Please note that while housing is guaranteed for Dual Degree Program students, you should not assume you have housing until you receive an offer letter or email from Columbia Residential.

IMMUNIZATION COMPLIANCE

Prerequisite: University Network ID (UNI)*

Timeline: 15-30 days once documentation has been submitted.*

***Though documentation cannot be submitted until you have a UNI, we recommend you begin reviewing requirements and compiling information as soon as possible.**

New York State public health law and University policy require that all students complete several immunization requirements and submit documentation for review and clearance prior to registering for their first term. These requirements include measles, mumps, and rubella (MMR) and meningitis. The flu vaccine is also strongly recommended. The completion of these requirements uses your UNI and password, though you should begin collecting necessary documentation immediately, as the process can take some time. **Once you've submitted documentation for review, final clearance can take up to 30 days. You cannot register for classes until your documents have been reviewed and accepted.**

COLUMBIA UNIVERSITY STUDENT HEALTH INSURANCE

Having health insurance is key to helping ensure predictable health care costs and to supporting students in the achievement of their personal and academic goals. In an effort to reinforce this aim, Columbia requires most students to have comprehensive health insurance as part of their enrollment in the University. All full-time domestic students and all international students are automatically enrolled in the Columbia University Student Health Insurance Plan.

DOMESTIC STUDENTS

Domestic full-time students may request a waiver from enrollment in the Columbia University Student Health Insurance Plan by submitting a request online before the open enrollment deadline. All requests are considered but approval is not guaranteed. Students may be asked to provide documentation of alternate coverage under a comparable plan. Please note that requests are considered on a case-by-case basis and approval is not guaranteed.

Columbia University reserves the right to verify the health insurance information you have provided. If your plan does not meet the University requirements, you will be enrolled in the Columbia University Student Health Insurance Plan.

Students who wish to request a waiver should review their alternate coverage to determine whether it meets all of the following criteria:

- The plan must meet the requirements of the Affordable Care Act, including coverage for routine, urgent, and emergent care for all of the act's Essential Health Benefits in New York State. For a description of the act's Essential Health Benefits, read [Compare Your Coverage](#).
- The plan must be licensed to do business in the United States.
- The plan must be effective and remain in force for the duration of the academic year (August 15, 2026 – August 14, 2027 for the upcoming academic year)

INTERNATIONAL STUDENTS

International students are not permitted to waive the Columbia University Student Health Insurance Plan unless covered by a U.S.-based, Affordable Care Act-compliant, employer-sponsored plan that meets all of the waiver criteria above. International students are defined as any enrolled student that is not a U.S. Citizen or Permanent Resident. All international students, regardless of the number of enrolled credits, will be enrolled in the Columbia University Student Health Insurance Plan.

VISA CERTIFICATION INFORMATION

INTERNATIONAL STUDENTS AND SCHOLARS OFFICE

The International Students and Scholars Office (ISSO) offers many services for the international community of students, interns, and scholars at Columbia University.

APPLYING FOR A CERTIFICATE OF ELIGIBILITY (I-20)

International students at Columbia enter the United States on an F-1 student visa. You will need an I-20 form issued by Columbia's International Students and Scholars Office (ISSO) before making your visa appointment at a U.S. consulate to apply for your F-1 visa. You will need to:

- Prepare your [supporting documents](#).
- Log in to Compass to [apply for your I-20 or DS-2019](#) using your PID or UNI. Refer to the [Compass User Guide](#) for additional information.
- Receive your I-20 electronically by email.
- [Apply for Your Visa](#) at a U.S. Consulate. The visa cannot be issued more than 120 days in advance of your program start date).

PEER SUPPORT FOR DUAL BA STUDENTS

There are a wide variety of Student Life initiatives to help your transition to Columbia. Your fellow students are committed to ensuring that you have a seamless transition, and are here to support you during your time on campus.

MENTORSHIP AND PEER ADVISING

In addition to the comprehensive advising offered by their GS academic advisors through all four years of the program, Dual BA students in years three and four also have access to the [GS Peer Advisors](#). Peer Advisors are undergraduate students who wish to provide support and advice for other GS undergrads about the opportunities and challenges at Columbia. Peer Advisors are available to discuss academics, campus resources, personal concerns, and the transition to the School of General Studies.

Peer Advisors are available to meet with students by appointment, and they also hold weekly walk-in hours in the GS Lounge.

Students also have access to the [GS Mentor Program](#), which pairs specially-trained continuing students from both the undergraduate and Postbaccalaureate Premedical programs with incoming students on the basis of several criteria including academic tracks, extracurricular interests, and personal backgrounds. Mentors meet with their mentees at regular intervals throughout their first semester.

DUAL BA PROGRAMMING AND EVENTS

Throughout the fall and spring semester, you will be informed of a variety of Dual BA and GS-specific events, focused on getting to know other students, stress and wellness, alumni and career engagement, fellowships and graduate school coaching, and more.

JUMPSTART & UNIVERSITY STUDIES

At GS, we understand that learning to navigate a new environment can be both exciting and challenging. This can be especially true for students in our dual and joint degree programs. The transition to New York offers an opportunity to immerse yourself in Columbia's community and academic culture, engaging with world-class faculty and a plethora of research and learning opportunities. At the same time, after spending two years learning to be successful on other campuses, stepping into the Columbia classroom can sometimes feel like the rules have changed and the foundation has shifted.

As you make your transition to campus, the GS Academic Resource Center (ARC) is here to support you. Our approach is centered around the belief that academic support is an important and necessary part of any learning process. Our goal is to be a resource for every student, at every point along the road to academic excellence. All of our programs and services have been designed based on the latest research in metacognition, educational psychology, and learning science, tailored to meet the needs of our returning student population and the Columbia classroom experience.

JUMPSTART

Jumpstart is a pre-Orientation Series that offers a preview of the Columbia undergraduate experience, including a combination of mock seminars, keynote faculty lectures, skill-building workshops, and community events. The series runs the week before Orientation and students are welcome to attend as many or as few events as work for your schedule.

UNIVERSITY STUDIES

Once classes begin, University Studies picks up where Jumpstart leaves off, offering a zero-credit, discussion-based course exploring together questions like what it means to be a student at an Ivy League university, what are our responsibilities as part of a research and learning community, and what are the University's responsibilities towards its students. University Studies also introduces the essential partners and resources at your disposal.

Students transitioning to Columbia will also be required to maintain their registration status at Trinity. Failure to maintain your administrative registration in years three and four will result in delays in the conferral of both your Trinity College and Columbia University diplomas.
